## Brown Marmorated Stink Bug (BMSB) Season 2019-20

Dear Valued Customers,

Further to our previous correspondence regarding the 2019-20 BMSB season as many of you would now be aware the measures and processes for LCL/FAK container containers have now been finalised by the Department of Agriculture.

### BMSB Season 2019-20

The 2019-20 season will commence ATD Target Risk countries 1st September 2019 until ATA Australian waters 31st May 2020.

### **Treatment**

During the 2018-19 season extensive delays were caused by cargo misdeclarations therefore to minimise the delays for the 2019-20 season AGS World Transport will treat containers from Target Risk countries at FCL level offshore where possible. The below table outlines our treatment locations, treatment method and associated costs for our Direct Services which will be applied to all cargo moving from or via these locations.

Your Declaration will be passed on to the Department of Agriculture as part of the Master Consolidators declaration at destination to gain release of the container. A no declaration no load policy will apply.

#### Canada

Arrangements for Canada are yet to be finalised due to the limited number of treatment providers available. Once confirmed we will advise further.

## Singapore

We are able to confirm in conjunction with our Singapore partners we will be offering a treatment option in Singapore. Cargo will be treated at LCL level prior to movement to Australia. Treatment costs in Singapore will be as follows:-

As the Department of Agriculture will be assessing risk based on the load port lodged in your Sea Cargo Automation lodgment, a BMSB declaration will be required for all cargo booked in Singapore. A copy of this BMSB declaration will be lodged with the Department of Agriculture along with our Master Consolidators declaration to enable release of the container. No declaration no load policy will apply.

### **Arrival Costs**

AGS World Transport will be applying a BMSB processing fee of A\$15 Per HBL for all cargo Shipped from or loaded via Target Risk Countries.
